During the calendar year 2019, Pharmaceutical Biotechnology: Current Research received a total of 30 papers, out of which 6 articles were rejected in the preliminary screening due to plagiarism or being

out of the format and peer review process. During 2019 around 9 articles were subjected for publication after they are accepted in the peer review process. In the 3 issues of Volume 3 published during the year 2019, a total of 9 articles were published (at an average of 3 articles per issue of which, articles were published from authors all around the world. A total of 30 research scientists from all over the world reviewed the 9 articles published in volume 3. Average publication period of an article was further reduced to 14-21 days.

During the calendar year 2019, a total of three Editors, ten Reviewers joined the board of PBCR and contributed their valuable services towards contribution as well as publication of articles, and their valuable reviewer comments will beneficial to publish quality of article in the Journal.

I take this opportunity to acknowledge the contribution of Editor-in-chief and Associate Editor during the final editing of articles published and bringing out issues of PBCR in time.
