



Model Pharmacy and Model Medicine Shop – a way of good pharmacy practice in Bangladesh

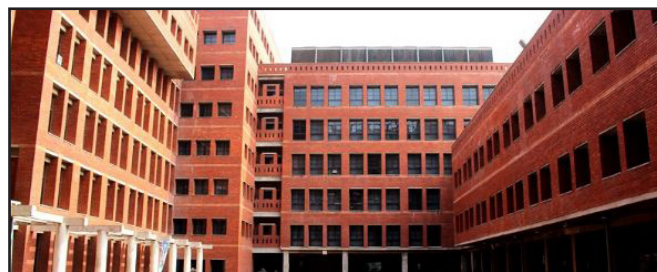
